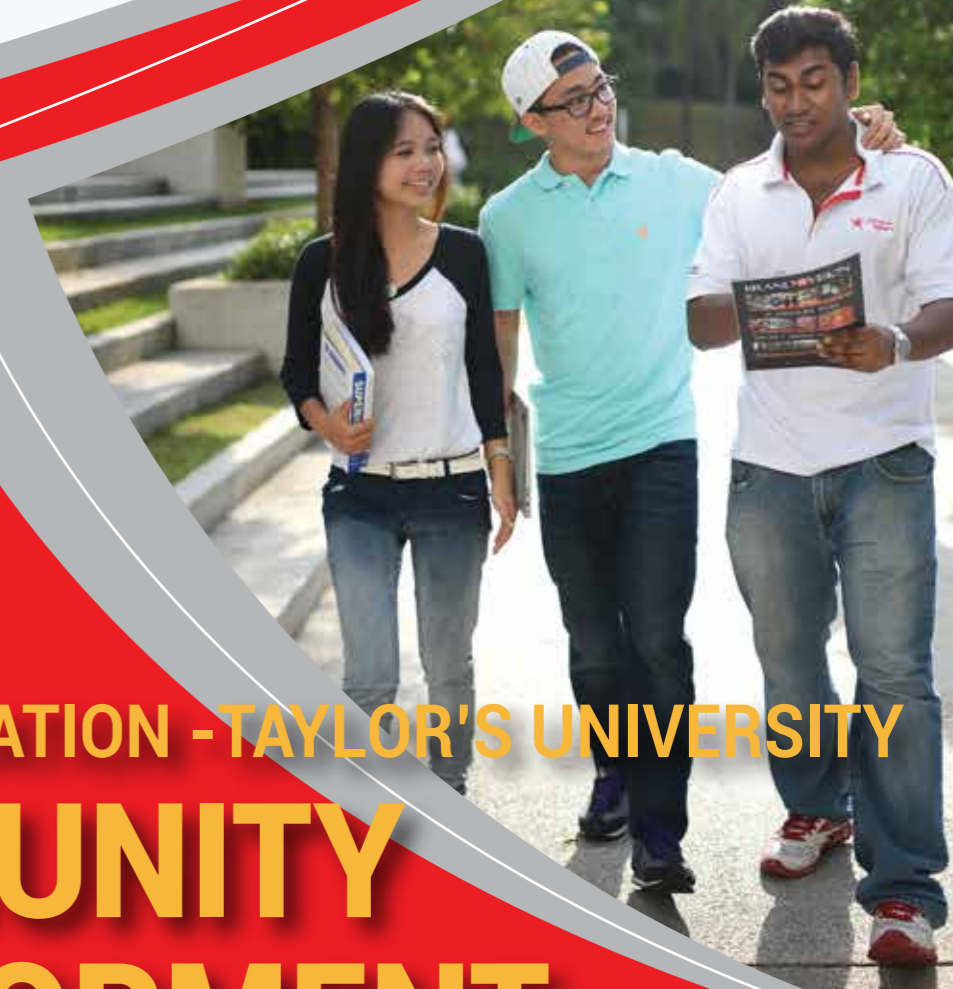


TERMS & CONDITIONS

1. This Scholarship is awarded by Taylor's University to deserving students from the Indian community.
2. This Scholarship is applicable for the July and August 2016 intakes only.
3. All applicants must meet the minimum entry requirements into the selected programme.
4. All applications are based on ACTUAL examination results.
5. All the scholarship / bursary applications must fulfil the scholarship / bursary requirements.
6. All scholarships, bursaries and grants offered by Taylor's University to any student are at the absolute discretion of Taylor's University Bursary Committee.
7. All scholarships / bursaries / waivers offered by Taylor's University are subject to the terms and conditions.
8. The University reserves the right to decide on the number of scholarships to be awarded.
9. Students are entitled to only ONE (1) scholarship / bursary / waiver at any one time, including sponsorship from other institutions/bodies. The one with the highest quantum will automatically apply. However, students are still entitled to the alumni family discount.
10. This Scholarship offered is valid for the duration of the programme offered and strictly cannot be transferred to any other programmes at Taylor's University.
11. In the event the student withdraws from the programme before completion, this Scholarship will be discontinued immediately.
12. Scholarship and study grant recipients are required to meet a minimum CGPA 3.00 at the end of each academic year in order to enjoy the scholarship / study grant in the subsequent year (where relevant). Failure to meet such academic requirement will have the scholarship / study grant terminated.
13. Where applicable, scholarship recipients will be required to sign an agreement accepting the terms and conditions of the scholarship.
14. Scholarship recipients who fail to comply with all the terms and conditions of the scholarship will be required to pay back 100% of the total scholarship amount disbursed to him / her by Taylor's University.
15. Selected scholarship recipients are required to undergo development programmes designed for them during their course of studies, in order to continue their scholarship in the subsequent year.
16. The successful applicant is required to pay all fees due (after deduction of any tuition fee waiver, if applicable) upon registration.
17. All scholarships / bursaries are applicable for studies at Taylor's University in Malaysia only and are not applicable for the period of study at overseas partner universities.
18. Taylor's University reserves the right to review the Scholarship awarded. In exceptional cases, this Scholarship may be withdrawn at any time in the event of gross misconduct or failure to meet the required academic grades.
19. The Bursary Committee reserves the right to reject incomplete application forms.
20. All applications must be received by the stipulated deadline. Late submissions will not be considered.
21. The terms and conditions of this scholarship may be modified and amended from time to time as deemed appropriate by Taylor's University and / or AMMA Foundation.
22. On all matters pertaining to the award of this Scholarship, the decision of Taylor's University shall be final and binding.
